

This year's theme meant to bring together rich areas of new research and timely lines of inquiry in Jewish studies—ranging from the psychological, somatic, and geographic, to the sociopolitical, ethical, and theological. How is the inner life (in its emotional, cognitive, experiential, and unconscious aspects) understood in relation to the body and the self's presentation to the outer world (intention/act; eating; sexuality)? How has space been constructed and conceptualized so as to create insides and outsides, private and public spheres? What is it to be "at home"—for an individual, a community, or a people—and what is gained and lost in being so? What ethical issues are raised by the creation or erasure of a boundary between inside and outside? How might God or the world be thought of as inside or outside with relation to the other?
